Muslim Sectarianism versus the De-escalation of Sectarianism in Malaysia

EXECUTIVE SUMMARY

- In 1992, a group of academics at the National University of Malaysia (UKM) organized a seminar titled “Seminar Ahli Sunnah dan Syiah Imamiyyah” (“Seminar on Ahl al-Sunnah and Imami Shi’ism”) in Kuala Lumpur. It aimed to demonize Shi’a Muslims and ban Shi’ism, effectively escalating sectarianism in Muslim society.
- A Deobandi presenter at the seminar by the name of Muhammad Asri Yusoff put forth arguments about Shi’ism, which later became the “intellectual base” for the discrimination and repression of Shi’a Muslims by Islamic authorities in Malaysia. This repression continues till the present day, and other religious leaders—particularly those with a Salafi orientation—take part in this.
- While much attention has been given to those who have escalated sectarianism, there have also been efforts to de-escalate sectarianism. These efforts come from groups such as Persatuan Ulama Malaysia, and individuals such as Abdul Hadi Awang of PAS, former Prime Minister Mahathir Mohamad, the leader of International Movement for a Just World, Chandra Muzaffar, as well as Malaysian academic, Syed Farid Alatas.
- Nevertheless, the roots of sectarianism have been deeply laid since the seminar in 1992. Unsurprisingly, the sectarian campaign against Shi’as is aligned with the agenda of extremist and terrorist organizations such as ISIS. The sectarian campaign thus arguably emboldens such groups and puts Malaysia and the entire Southeast Asia at risk.

INTRODUCTION

In 1992, a group of academics from the National University of Malaysia (UKM) organized a seminar titled “Seminar Ahli Sunnah dan Syiah Imamiyyah” (“Seminar on Ahl al-Sunnah and Imami Shi’ism”) in Kuala Lumpur. The two-day event arguably aimed to demonize the Shi’a sect and its adherents, as evident from the content of the presentations which will be discussed below. Among the various presenters was Wan Zahidi Wan Teh (1992, pp. 1–34), a lecturer from the Department of Shariah who presented a paper on “Ahlul Bait Menurut Pandangan Sunnah dan Syiah” (“The Prophet’s Household According to Sunnis and Shi’as”).² After a lengthy explanation of his own understanding of the *Ahlul Bait*, he argued that Shi’as should not have the right to talk about the *Ahlul Bait*, and he dismissed them as a movement founded by Jews. He then quoted the founder of Wahhabism, Imam Muhammad bin Abdul Wahhab, and referred to Shi’as as apostates (*ibid.*, p. 30). Proclaiming himself as a defender of Islam, he concluded that the goal of Shi’as in Malaysia was

to cause Muslims to deviate from the Islamic creed, and to destabilize Muslim society through an underground movement in the country (ibid.).

Another paper titled “Bahaya Syiah Kepada Aqidah, Syariah, Akhlak, Ummah dan Negara” (“The Dangers of Shi’ism to the Islamic Creed, Shariah, Ethics, Muslim Society and the Nation”) was presented by a renowned Malaysian Deobandi scholar, Muhammad Asri Yusoff (1992, pp. 4–41).³ He began his paper by saying that “the truth is that Shi’ism is a teaching that has long been planned and organized by the enemies of Islam. It is the product and fruit of poisonous trees that were planted by Islam’s enemies in Muslim lands.” Arguably, Muhammad Asri’s paper was not presented according to academic conventions. He did not provide any framework or methodology, and his only argument was that Shi’ism was founded by a Jew by the name of Abdullah bin Saba, and is therefore inimical to Islam and Muslims as a whole.⁴

There was only one paper that presented a more objective and balanced view of Shi’ism. In his paper titled “Asal-Usual Syi’ah Imamah Daripada Perspektif Sejarah dan Budaya Awal Islam Hingga Tahun 40H/660M” (“The Origins of Imamate Shi’ism from the Perspective of the Early History and Culture of Islam to 40H/660CE”), Ismail Abdul Halim examined the similarities between Sunni and Shi’a Islam and stated that both sects believe in Imam Mahdi as the saviour of humankind (ibid., p. 83). Stating that “Muslims today need to look for similarities across the various streams of thought in Islam,” he emphasized that there should be an end to the publication of materials which insult any sect

within Islam, be it Sunni Islam, Imami Shi'ism, or Zaydi Shi'ism (ibid.). In fact, he encouraged students in institutes of higher learning to engage in debates on Shi'ism and to understand the historical reasons behind the schisms between the two major sects.

However, it appeared that his arguments and suggestions were not received well, and his paper was not included when UKM published the proceedings of the seminar in 2009 as a book titled *Prosiding Seminar: Syiah Imamiyyah Mazhab ke-5? (Seminar Proceedings: Imami Shi'ism as a Fifth Sect?)*.⁵

This seminar is a glaring example of how sectarianism functions. Firstly, although the theme of the seminar was Imami Shi'ism, the organizers did not invite any Shi'a scholars to provide their own perspectives. Thus, there was no engagement with Shi'a representatives. Secondly, almost all of the papers were biased against Shi'ism and presented untrue information about it. Thirdly, the seminar laid the foundations for the development of a harsh attitude towards Shi'ism. In fact, it is possible that Muhammad Asri Yusoff's arguments became the "intellectual base" for the discrimination and repression of Shi'a Muslims by Islamic authorities in Malaysia which continues until today.

The seminar arguably also led to the issuing of a *fatwa* (legal opinion) which completely banned Shi'ism, and this *fatwa* was later gazetted to become part of the law in all states across Malaysia (Mohd Faizal Musa 2020).⁶ Released by the Fatwa Committee of the National Council for Islamic Affairs in Malaysia, it was decided that a 1984 *fatwa* accepting the Zaydi and Ja'fari creeds of Shi'ism would be repealed, and that the committee would:

- Determine that the Muslims in Malaysia should only follow the teachings of Islam which [is] based on the beliefs of Sunni Islam in Doctrine, Law and Islamic Morals.
- Support and accept the proposal to amend the Federal Constitution and State Constitutions—to provide expressly that the religion of the Federation and the States shall only be the religion of Islam based on the beliefs of Sunni Islam in Doctrine, Law and Islamic Morals.⁷
- Make provision for amendments to all State Law and Islamic Law to coordinate the Sharia definition of Islamic law to be as follows: “Sharia Law or Islamic law means the Islamic laws based on the beliefs of Sunni Islam in Doctrine, Law and Islamic Morals.”
- Recommend that Islamic teachings other than the beliefs of Sunni Islam are contrary to Shariah Law and Islamic Law hence the spread of any doctrine other than that of Sunni Islam is prohibited.
- Stipulate that all Muslims in this country are subject to Islamic Law based on the beliefs of Sunni Islam only.
- Determine that the publishing, broadcasting and distribution of any books, pamphlets, films, videos and others relating to the teachings of Islam which is [sic] opposed to the beliefs of Sunni Islam is prohibited. (Fatwa Committee of the National Council for Islamic Religious Affairs Malaysia 1996.)

This, therefore, marked a turning point for the development of a sectarian mode of thinking in Malaysia, which reached its peak during Najib Razak’s administration from 2010 to 2016. During his administration, dozens of Shi’as faced detention without trial, while others were subjected to raids on their private residences and community centres, harassment, book banning, and even an enforced disappearance in 2016, as evident from the case of a Shi’a activist from Perlis, Amri Che Mat. Today, Shi’as are subject to the Shariah Criminal Offenses Act.

Considering this, it is crucial to understand the roots of sectarianism in Malaysia, and why it persists to this day. This paper examines the development of sectarianism in Malaysia by focusing on the key players and networks involved in propagating sectarian ideas. However, while an understanding of the phenomenon and its manifestation in Malaysia is important, it is equally important to look at existing efforts to de-escalate sectarianism and to promote Islamic ecumenicism. This will be done in subsequent sections of the paper, which introduce key players from different sections of society who have been involved in de-escalating sectarianism.⁸

UNDERSTANDING SECTARIANISM AND ISLAMIC ECUMENICISM

Sectarianism can be defined as “a whole cluster of ideas, beliefs, myths and demonology about religious difference which are used to make religion a social marker, to assign different attributes to various religious groups and to make derogatory remarks about others. It is more than a set of prejudiced attitudes but refers to behaviours, policies and types of treatment that are informed by religious difference” (Jarman 2012, p. 4). According to this definition, sectarianism certainly exists in the Malaysian Muslim context.

Higgins and Brewer (2003, p. 107) argue that sectarianism operates at three levels; as ideas, as individual action, and as a social structure: “at the level of ideas it is expressed in negative stereotypes and pejorative beliefs and language about members of another religion. At the level of individual action, it shows itself in direct discrimination and various types of intimidation and harassment against members of another religion

because of their group membership. At the social structural level, it expresses itself in patterns of indirect and institutional discrimination and disadvantage.”

In the case of Malaysia as described earlier, sectarianism functions on all three levels. The statements made about Shi’ism at the seminar in 1992 and which continue to be propagated till today are proof of the functioning of sectarianism at the level of ideas, and the harassment that Shi’as face in their daily religious life is indicative of sectarianism at the level of individual action. What is most alarming, however, is how sectarianism manifests at the social structural level in the form of raids conducted by religious authorities, and the policies which they introduce.

Morten Valbjørn has argued that “where there is a Sunni/Shi’a divide, sectarianism can be used as part of a range of different kinds of authoritarian techniques” (2019, p. 137). Although Malaysia is a democratic country, the Islamic authorities, who are Sunni, may be said to be manipulating “social dynamics” to stay relevant. This may result in some religious authorities seeking to uphold the status quo to ensure the loyalty of their congregants. For example, in defending the decision to ban Shi’ism, the mufti of Perak reasoned that it is justified as “we are now safe, why do we want to convert to a different sect, this issue arose because there are people among us who are easily influenced and have a tendency to show off” (Faiz Zainudin 2019).

Malaysian religious authorities have also admitted to playing the sectarian card as a “survival strategy”, a response to the growing rejection among youths towards institutionalized religion (Valbjørn 2019, p. 141). In order to survive, they peddle untruths about other groups. For example, the Director-General of the Department of Islamic Development Malaysia (JAKIM), Othman Mustapha, claimed that Malaysian Sunnis are attracted to certain lenient aspects of Shi’ism, such as the lack of a requirement to attend Friday prayers, the ability to engage in a contract marriage, the ease of praying three times daily instead of five, and getting married without a dowry (Bernama 2013).

Such statements are untrue allegations, which are indicative of the failure of religious authorities to cross-check their sources, their lack of dialogue with Shi’as, and the absence of critical reasoning. As argued

by Ziauddin Sardar and Merryl Wyn Davies (2014, p. 15), these are important criteria to consider in countering sectarianism.⁹

The fanning of sectarianism in the contemporary Muslim world is very much related to the formation of Saudi Arabia in 1744. According to David Commins, “when the first Saudi state (1744 to 1818) conquered much of Arabia in the name of wiping out polytheism, its enemies were other Sunnis (including Hanbalis who rejected Sheikh Muhammad’s preaching), recast as infidels according to Wahhabi doctrine. Under the second Saudi state (1824 to 1891), Wahhabi clerics strove to exclude corrupt external influence by declaring a ban on travel to infidel lands, fingering not to Europe, but to neighbouring, mostly Sunni, Arab territories” (2021, pp. 23–26). It was only under the third Saudi state from 1902 that they chose to be more open towards other Sunnis in order to gain recognition from other Muslim nations. They then actively propagated Wahhabism through pan-Islamic missionaries, thus exporting Wahhabism and sectarianism outside their borders. This became especially prevalent after the Iranian Revolution in 1979, which led to Shi’as in Saudi Arabia becoming the victims of repression and discriminatory policies.¹⁰ Consequently, Wahhabism has been misunderstood by some to be mainstream Sunni Islam, while other Muslims such as Shi’as are portrayed as infidels (*ibid.*).

The opposite of sectarianism is Islamic ecumenicism, which Muslim clerics refer to as *taqrib* (proximity, intra-faith reconciliation, or Sunni-Shi’a rapprochement). For the purpose of this paper, I will refer to it as

the practice of de-escalating sectarianism. Ibrahim Kazerooni, an imam at the Islamic Center of America and a faculty member of the University of Detroit Mercy explains that the objective of *taqrib* is to “explore the possibility of ground-breaking dialogue that bridges the divide and narrows the divergence that has come to exist between the various schools of thought in Islam” (2021, p. 37).

However, the idea or promotion of *taqrib* is complicated by the policy of the United States (US) in the Middle East. As a result of the presence of the US in the region, some Muslim clerics are receptive to the idea of Islamic rapprochement because sectarianism is the work of the “colonialists, Zionists,” and Western powers who “caused the split of the Muslim ummah” (Hersh 2007). Thus, these clerics are more against the colonial agenda of “divide and rule” than they are interested in the proximity between the various schools of thought within Islam. As Kazerooni puts it:

The importance of the concept of *taqrib* has become urgent especially in the light of the political upheaval ensuing from the occupation of Iraq and the war in Syria, where a unique narrative has gained currency among academics and the general public, which is that the crisis in the Middle East is inherently a sectarian issue that has been there from time immemorial. This kind of narrative not only is factually inaccurate, but also is politically useful for the colonial powers, especially the United States in this case, to deny any responsibility for the crisis of sectarian violence that they themselves have deliberately created as part of the official policy in the region (2021, p. 37).

The project of promoting Islamic ecumenicism is therefore a mammoth effort, as it is connected to the global and regional political order. As Rainer Brunner has stated, it is easier to be a polemicist (and therefore a sectarianist), than to be a conciliator (or a de-escalator of sectarianism) (2021, pp. 15–20).

Furthermore, Muslim clerics who work to promote *taqrib* and “bridgebuilding between various schools of Islam” usually face strong resistance from *takfiri* clerics who are more orthodox and rigid, and who

tend to declare other Muslims as apostates. While both groups of clerics organize conferences, publish journals, and hold gatherings for religious leaders from across the Muslim world, the former does so in order to promote bridge building, while the latter disavows such an objective (Kazerooni 2021, p. 40).

In some cases, the tensions between the proponents of *taqrib* and *takfir* have led to violence. For example, a Shi'a cleric by the name of Ayatullah Muhammad Baqir al-Hakim, who was an iconic figure in intra-religious ecumenical projects, as well as a Sunni cleric by the name of Shaykh Muhammad Sa'id Ramadan al-Bouti who was well known for promoting Sunni-Shi'a rapprochement, were both killed by *takfiri* Wahhabi militants from Al-Qaeda and ISIS in 2003 and 2013 respectively (Mohammad Sagha 2021, pp. 45–46).¹¹

While such violence may not be prevalent among Muslims in Southeast Asia, there is certainly tension between the *taqrib* and *takfiri* groups in Malaysia, which has also had an impact on Muslims in Singapore.¹²

THE MALAYSIAN SECTARIANIST: CONNECTIONS TO SAUDI ARABIA AND PAKISTAN

In 1906, R.J. Wilkinson made the following observation about Malays while he was residing in British Malaya:

The Malays are consequently Sunnites like the Moslems of the Deccan; but Persian influence has been so great throughout India that even the Indian Sunnites have become infected with Shiite

“heresies”. In the Malay Peninsula traces of Shiite influence are visible in the Muharram festivities, in the peculiar respect paid to Ali, Hasan and Husain, and in the tone of much of the old Malay Literature. In the matter of religious law the Malays are Shafeites. These explanations of the Malay religious stand-point are, however, somewhat technical; the average native of the Peninsula is generally unaware of the existence of rival Musulman sects and of the divergence of his creed from the truer Sunnite beliefs (1957, pp. 1–2).

He therefore made the observation that Malays paid little attention to the intra-religious differences between them. Up until the establishment of JAKIM, sectarianism was not an issue in Malaysia. It was not uncommon for Muslims to change their school of law when deliberating on a particular issue, and there were Muslim figures who encouraged harmony between Sunnis and Shi’as.¹³

For example, in 1953, Za’ba, a well-known linguist, writer and religious figure, stated in an article that Muslims should be more tolerant of the different schools of thought, including Shi’ism, and that the Malays

should be more pluralistic in engaging with the various schools of thought (Za'ba 2009, p. 138).¹⁴ Additionally, on 2 October 1960, the leader of Parti Islam Se-Malaysia (PAS), Burhanuddin al-Helmi, in his opening speech for “Kongres Ahli-Ahli Tarikat As-Sufiah Seluruh Malaya” (“All-Malaya Congress for Members of the Sufi Order”), reminded the audience that Muslims need to avoid clashes between Sunnis and Shi’as, as such division is created by “greedy rulers” (Burhanuddin al-Helmi 2005, p. 39).

However, sectarianism eventually developed in Malaysia, and it arguably has its roots in the modern version of the *takfiri* framework of excommunicating other Muslims which has its origins in the formation of Saudi Arabia. As a result of the expansion of Saudi power, the Saudis were able to export Wahhabism to other parts of the world.¹⁵ As Ahmad Fauzi Abdul Hamid has said, “under the guise of ummatic unity, Saudi institutions such as the Rabitah al-‘Alam Islami (MWL, Muslim World League) and the World Assembly of Muslim Youth (WAMY) have served as conduits for exporting Wahhabi dogma worldwide. The transmission process in Southeast Asia has been well-documented, penetrating structures of Muslim states, ruling parties, charity associations, non-governmental organizations, Islamist movements and educational networks” (2016, p. 8).¹⁶

From a sociological perspective, the Wahhabi approach towards reforming religion and society is considered extreme. Syed Farid Alatas, a prominent Malaysian sociologist who is vocal against sectarianism, has underlined five Wahhabi traits which are indicative of an extremist orientation:

The main traits of such extremism include the following: intolerance of others, particularly Muslims who disagree with their orientations; overemphasis on rules and regulations at the expense of spirituality; forbidding beliefs and practices allowed by the majority of Muslims; non-contextual; and non-historical interpretation of Qur'an and Hadith, and literalism in the interpretation of texts (Alatas 2009, pp. 9–10).

Intolerance of others, specifically other Muslims, and therefore sectarianism, is therefore an extremist trait. As Sanchita Bhattacharya has put it, “the word sectarianism is derived from sect, which means body of people having varied views within the same religion. Sectarianism means observance of the rules of a particular sect or party, especially in a bigoted or narrow-minded way” (2019, p. 88).

Saudi Arabia has also had an influence on the development of Islam and sectarianism in Pakistan. Alexander Alexiev highlighted that Saudi financial support from the early 1980s had contributed to the establishment of thousands of Ahle Hadith¹⁷ and radical Deobandi religious schools and organizations under government auspices. He argues that this contributed decisively to the “wholesale Islamization of Pakistan and its transformation into a jihadist breeding ground in the last two decades of the twentieth century” (2011, p. 45). Arif Rafiq has also pointed out how “ultimately, the confluence of three nearly concurrent events gave birth to the phenomenon of sectarian violence in Pakistan today: the 1977 coup by General Zia ul-Haq and his subsequent Sunni-

tinged Islamization programme; the 1979 Islamic Revolution in Iran and moves by Tehran to export its ideology to Shi'i communities elsewhere; and the 1979 Soviet invasion of Afghanistan and the development of a vast Sunni, later Deobandi, jihadi infrastructure inside Pakistan" (2014, p. 16).¹⁸

This is crucial information, as Muhammad Asri Yusoff was a Deobandi. He arrived at Darul 'Ulum Deoband, India on 22 September 1977 to pursue his studies, after which he continued his studies at Jamiatul Darul 'Uloom in Karachi, Pakistan. It is important to note here that "Sunni Deobandi militant groups are the driving force for Pakistan's growing sectarian violence. Lashkar-e Jhangvi and the Tehreek-e-Taliban Pakistan seek the official declaration of Pakistan's Shi'a as non-Muslims and work to exterminate large numbers of Shi'a to make the remaining population subservient. While the Ahle Sunnat Wal Jamaat organization also seeks to make Shi'as second-class citizens in Pakistan, it makes greater use of political activities and street agitation to press for its demands" (Arif Rafiq 2014, p. 4). Furthermore, Jamiatul Darul 'Uloom Karachi has been listed as an institution that promotes violent jihad (International Crisis Group 2007, p. 8). It is therefore possible that these factors shaped Muhammad Asri's thinking on intra-Muslim issues. In fact, his earliest publications are laden with sectarian tendencies, in which he focuses on criticizing Shi'ism (Faisal bin Ahmad Shah 2009, p. 175). He continues to propagate this sectarian mode of thinking from the pulpit at his religious school,¹⁹ Darul Kautsar, in Kelantan.

This is problematic, as his views have been adopted by JAKIM. For example, he claimed that Shi'as have their own Qur'an, which is different from the one Sunnis have (1996, pp. 12, 194–200). JAKIM supported this claim, stating that Shi'as believe that "the Qur'an has been distorted,

whether in the form of omissions or additions, as well as the belief that the Qur'an contains 17 thousand verses" (JAKIM 2012).²⁰ Such claims are laughable and illogical,²¹ and a simple observation of all the Iranians who have won the International Qur'an Recital Competition organized by Malaysia is enough proof of their knowledge of the Qur'an.²²

Another claim made by Asri during the seminar at UKM in 1992 was that "the presence of Shi'as will create disunity among Muslims as they believe the Sunnis who hold steadfastly to the Qur'an and Sunnah are non-believers and are worse than the devil." He further claimed that Shi'as believe that it is permissible to murder Sunnis (1996, pp. 28, 31, 34).²³ This was reiterated by the director of the Selangor Islamic Religious Department (JAIS), Muhammed Khusrin Munawi, in the aftermath of a JAIS raid on a Shi'a centre during the commemoration of Ashura on 15 December 2010. This raid on Hauzah ar-Redha in Gombak, Selangor, resulted in the arrest of 200 Shi'as, including a local scholar and a visiting scholar from Iran (*Utusan Malaysia*, 17 December 2010).

Such claims are baseless. Commenting on such claims, Syed Farid Alatas firmly stated that:

Anti-Shi'ite hate speech is supported by assertions about Shi'ism that are simply untruths. For example, Shi'ites are said to have their own Qur'an. This continues to be repeated by anti-Shi'ite propagandists despite the fact that evidence of the existence of a Shi'ite Qur'an has never been produced. It is also said that Shi'ism is a religion created by a Yemeni Jew more than 1,400 years ago in Arabia in order to split the early Muslim community. A director of one of the state religious departments in Malaysia reportedly stated that Shi'ites are "fanatics and a threat to national security". This idea was repeated on various occasions by Malaysia's state-dominated media, although Malaysian security itself had never produced such evidence. The same director is also reported to have said that for the Shi'ites, "the blood of the followers of other faiths is lawful and it means that adherents of the followers of Sunnah Wal Jamaah could be killed." While it is true that there are legitimate doctrinal differences between Sunni and Shi'ite Islam that can be discussed in an open and scholarly manner, the anti-Shi'ite literature originating from Malaysia and elsewhere generally presents a distortion or caricature of Shi'ism and attacks that caricature (2017).

The mufti of Perlis, Mohd Asri Zainal Abidin, also known as MAZA, is also known for his sectarian tendencies. In fact, MAZA appeared on stage together with Muhammad Asri Yusoff at a seminar on "The Dangers of Shi'ism", held at the International Islamic University Malaysia (IIUM) on 3 January 2004. Like many other sermons and presentations delivered by MAZA, the recording of this seminar is available online.²⁴

The content of MAZA's anti-Shi'a sermons tends to focus on propagating untruths about Shi'ism and alienating Shi'as. Examples of these sermons that are available online include "Siapa Syiah? Amerika Akan Menyerang Iran?" ("Who are the Shi'as? Will US Attack Iran?", 2011), "Sejarah Pahit Antara Sunni dan Syiah" ("The Bitter History between Sunnis and Shi'as", 2012), "Syiah Adalah Satu Ajaran Yang Sesat" ("Shi'ism is a Deviant Teaching", 2013), "Syiah Semua Sesat, Sebahagian Kufur" ("Shi'as are All Heretics, Many of them are Unbelievers", 2013), and "Pendirian Saya Tentang Syiah" ("My Opinion on Shi'ism", 2019).

One of the topics that MAZA appears to be particularly interested in is that of *qama zani*, or the ritual of self-flagellation as the expression of one's grief for Imam Husayn and how he was murdered during the Battle of Karbala.²⁵ MAZA argues that this ritual is indicative of the fact that Shi'as are deviant, full of vengeance, and willing to shed blood.²⁶ However, he conveniently ignores the fact that Shi'a clerics themselves have warned against such harmful self-flagellation, labelling it as extreme. For example, in 1927, Sayyid Muhsin al-Amin al-Amili, a Shi'a cleric from Lebanon residing in Najaf at the time, wrote a pamphlet condemning the ritual.²⁷

However, such a mode of thinking is not limited to individual religious figures, and is even prevalent among politicians. For example, in 2013, sectarianism intensified when Ahmad Zahid Hamidi, then the Minister of Home Affairs, announced the intention to amend the Constitution such that Sunni Islam would be the only legitimate school of thought. Additionally, during the ruling party's (United Malays National Organization, or UMNO) general assembly that year, UMNO leaders called for the eradication of Shi'as in the country. The assembly was attended by Sheikh Khalid Ali Al-Ghomidi, an imam from Mecca. In his speech after congregational prayers, he praised Malaysia for its efforts to curb the spread of Shi'ism (*Utusan Malaysia*, 8 September 2013, pp. 1, 5).

Anti-Shi'a sentiments and hatred have also permeated into right-wing non-governmental organizations (NGOs) such as Pertubuhan Muafakat Sejahtera Masyarakat Malaysia (Muafakat), which has consistently organized seminars to "educate the public" on the dangers of Shi'ism (Muafakat Malaysia 2013). For example, on 8 September 2013, Muafakat organized a seminar on "Facing the Shi'a Virus". Open to the public and held at a state-owned facility in Kuala Lumpur, they invited the Assistant Secretary of the Ministry of Security and Public Order, Zamihan Mat Zin Al-Ghari, to speak about the topic. He is known for his anti-Shi'a hate speeches.²⁸

Another NGO involved in such activities is Yayasan Dakwah Islamiah Malaysia (Islamic Da'wah Foundation of Malaysia, or YADIM). At an event organized by them in the state of Perlis, the head of the Perlis

State Religious Council (MAIPs), Mohamad Sokri Husin, bragged that they had “spotted” a Shi’a student, thus claiming that even teenagers in schools are not spared from the alleged ills of Shi’ism. A report on the seminar stated that MAIPs and JAKIM, together with YADIM, would subsequently organize a faith consolidation programme to raise awareness about the dangers of Shi’ism (*Sinar Harian*, 27 July 2013).

Ikatan Muslim Malaysia (ISMA) is yet another NGO that organizes such events. They even have a research department on Shi’a issues (“Unit Kajian Isu Syiah”). At a seminar organized on 30 November 2013, titled “Seminar Ancaman Serangan Akidah: Bahaya Syiah dan Liberalisme” (“Seminar on the Threat of the Shi’a Creed: Dangers of Shi’ism and Liberalism”), the president of the above-mentioned research department, Mohamad Ismail, claimed that foreign students from Iran were responsible for spreading Shi’ism in Malaysia.²⁹

Even groups which are perceived as more progressive have also been involved in propagating anti-Shi’a sentiments. For example, the Malaysian Islamic Youth Movement (ABIM) applauded the Ministry of Home Affairs for its “effective and swift actions” taken against the Shi’as. Additionally, ABIM conducts seminars with the aim to “help society understand more about Shi’a teachings”. For example, the Selangor branch of ABIM reported on their blog that they organized a seminar titled “Pemantapan Aqidah: Syiah itu Islam?” (“Strengthening the Faith: Is Shi’ism Considered as Islam?”), during which they invited Abdullah Din, the deputy president of the Kedah branch of the organization, to speak to a large crowd. One of the pictures on that same blog post was accompanied by the caption “anti-Shi’a seminar received encouraging reception”.³⁰

It is worth noting here that the King, who is the Head of State, did not do much to alleviate the situation. Amidst the government-led campaign against Shi'ism in 2013, the King at the time, Yang Di-Pertuan Agong Tuanku Abdul Halim Mu'adzam Shah, called upon all government quarters to pool their resources together in order to address the spread of Shi'ism in Malaysia (Bernama 2013).³¹

Following this, Friday sermons began to dehumanize Shi'as. For example, in a sermon titled "The Shi'ite Virus" scripted by JAKIM and delivered on 29 November 2013, Muslims were warned to comply with the 1996 *fatwa*, and were reminded that they must adhere only to the teachings of Sunni Islam. They were also urged to report to religious authorities if they "suspect, realize or witness for themselves the existence of any party that seeks to spread the teachings of the Shi'ite faith". The sermon emphasized that such efforts were introduced in the name of jihad to "maintain the sanctity of the religion" (JAKIM 2013). The sermon also included fabricated information about Shi'ism, such as allowing the act of sodomy (Hasbullah Awang Chik 2013).³²

THE MALAYSIAN EQUILIBRIST: EFFORTS TO DE-ESCALATE SECTARIANISM

To be sure, efforts have also been made to de-escalate sectarianism in Malaysia. In response to the seminar held by UKM in 1992, another seminar was jointly organized by Persatuan Ulama Malaysia (Ulama Association of Malaysia, or PUM), Majlis Kakitangan Islam Selangor dan Wilayah (Selangor and Wilayah Islamic Staff Council, or MAKKISW) and Gabungan Mahasiswa Islam Se-Malaysia (Malaysian Association of Muslim Students, or GAMIS) on 3 and 4 July 1993. Titled “Seminar Antarabangsa Pendekatan Mazhab Sunni-Syiah Dalam Konteks Kebangkitan Islam” (“International Seminar on Sunni-Shi’a Rapprochement in the Context of Islam Revivalism”), and attended by 600 participants, the seminar sought to counteract the information presented at the UKM seminar. It is worth noting that the seminar was attended by Shi’a clerics from Iran, such as Ayatullah Amini and the late Ayatullah Ali Al-Tashkiri, who both presented papers on de-escalating sectarianism and the significance of sectarianism as a tool used by Western powers to create disunity among Muslim nations (*Harakah* 1993, pp. 12–13).

Another speaker was the late Syed Hussin Habsyi, an Indonesian cleric who was also well known in Malaysia. In his paper entitled “Pendekatan Mazhab Sunni-Syiah (Syarat-Syaratnya)” (“Sunni-Shi’a Rapprochement [The Conditions]”), he stipulated eight steps to combat sectarianism, as briefly stated below:

- (1) Sunni-Shi’a dialogue which puts aside politics or any personal agenda; the sole purpose should be to elevate the Qur’an and Sunnah.
- (2) Such dialogue should be purely academic and should only involve learned clerics who have knowledge of the Ja’fari (Twelver Shi’ism), Zaidi, Ibadī and Dzohiri legal schools.
- (3) One is not to be fanatical towards one’s own legal school.
- (4) One should not impose one’s judgement on others, or compare the validity of one’s legal school to another.
- (5) One should have the awareness that all legal schools have enemies who are working to find their weakest point in order to bring them down.

- (6) One should not include the masses in such discussions, as their lack of theological knowledge may lead to confusion or the spread of misinformation.
- (7) One should not discuss the complex concepts and doctrines of other legal schools on one's own.
- (8) One should have the awareness that some factions of certain sects are indeed extreme and are not representative of that particular sect (1993, pp. 1–3).

Most importantly, Syed Hussin rejected the *takfiri* approach of excommunicating Shi'as or labelling them as deviant. He emphasized that events such as the seminar at which he was speaking should not be held for the purpose of criticizing others or promoting sectarianism, but should only be held with good intentions in mind.

Abdul Hadi Awang, the current president of PAS, also presented a paper entitled “Ancaman Kuasa Kuffar dan Konspirasi Musuh Islam (Langkah-Langkah Penangkisannya)” (“The Threat of Infidels and Conspiracies from the Enemies of Islam [Steps to Counter It]”).³³ In this paper, he stated that “the Muslim ummah must also avoid disputes with one another, including disputes with other sects whether Sunni or Shi'a, and avoid disputes on matters of the caliphate” (1993).³⁴

At the end of the seminar, an eighteen-point resolution to promote Sunni-Shi'a rapprochement was produced.³⁵ The deputy president of PUM concluded the seminar by suggesting that a secretariat be formed

to work on promoting Sunni-Shi'a rapprochement. Additionally, Ahmad Awang, the president of PUM, then gave a press conference, emphasizing that secularism was more dangerous than Shi'ism (Aziz Muda 1993, p. 7).³⁶

At this juncture, it is worth discussing Abdul Hadi Awang's presence at the seminar and his wider approach towards anti-sectarianism. As early as 1989, he expressed his fondness for Imam Khomeini, the leader of the 1979 Iranian Revolution, and referred to him as the "Muslim reformer of early 15th Hijri" (1989, p. 5). Under Abdul Hadi Awang's leadership, PAS chose to be on good terms with Iran and distanced itself from Wahhabi and Salafi-led powers. His stand did not change over the years. When the stigmatization of the Shi'as in Malaysia was at its height in 2013, he questioned why there was "a war against the Shi'a sect which has been around for more than a thousand years" and argued that this "strategy of divide and conquer" was a tactic to "save the West and Israel" from Iran's technological advances (2013).³⁷ In a short Facebook write-up in 2016, he further criticized those Muslims "who bring in the issue of *takfiri* because of the existence of nonsensical ideas which are linked to creed," and denounced government leaders who blindly propagate sectarian ideas (2016).³⁸ A year later, while discussing PAS'

Abdul Hadi Awang’s approach towards Sunni-Shi’a rapprochement is therefore unique as he navigates between theological arguments and geopolitical relations. This is interesting considering the fact that he obtained his first degree in Islamic Shariah from the Islamic University of Madinah in 1973, followed by a Master’s degree in Islamic Political Science from Al-Azhar University in Egypt in 1976.

both Sunnis and Shi’as, and have become the target of punitive weapons. Another politician who has played a big role in de-escalating sectarianism is Mahathir Mohamad, the former Prime Minister of Malaysia. Similar to Abdul Hadi Awang, Mahathir argues that sectarianism is a tool used by the “enemies of Islam” (2013).

It is first important to understand that Mahathir differentiates between Iran as a country and Shi’ism as theology. During Mahathir’s first period as Prime Minister, bilateral relations between Iran and Malaysia were steady. There were often visits by Iranian diplomats to Malaysia, and a Memorandum of Understanding was even signed when President Mohamad Khatami visited in July 2002. Furthermore, when Hassan Rohani became President in 2013, Mahathir was present at his inauguration ceremony, and expressed optimism that relations between the two countries would further improve (Asmady Idris and Remaly Yusoff 2015, p. 125).⁴⁰ It was also in the year 2013 that Mahathir made a joint statement with former President Khatami amid the increasing

During this visit, Tun Dr Mahathir congratulated the

persecution of Shi'as in Malaysia. Initiated by Chandra Muzaffar, the president of the NGO International Movement for a Just World (JUST), the part of the statement read:

Sunni-Shi'a animosity and antagonism have clearly weakened the Muslim ummah. It has made us more vulnerable to the manipulations and machinations of outside elements determined to subvert the unity and integrity of the ummah. It has allowed those who seek to establish their hegemonic power over us to succeed in their objectives. It is indisputable that Sunni-Shi'a antagonism and conflicts which have resulted in massacres have tarnished the image and dignity of the ummah in the eyes of the world. Few other occurrences in recent times have had such a negative impact. We appeal to all Sunnis and Shi'as, bound as we are by the same faith in Allah, guided by the same Noble Quran, honouring the same last Messenger of Allah, and facing the same Kiblah, to desist from massacring and killing one another immediately (S. Muhammad Khatami, Mahathir Mohamad and Chandra Muzaffar 2013).

The statement thus illustrates how both leaders had the view that sectarianism has been propagated by hegemonic powers, and that the only way to overcome this would be for Sunnis and Shi'as to work together in order to de-escalate sectarianism and uphold the unity of the global Muslim *ummah*. However, while the statement was circulated

online and widely reported locally and internationally, it failed to have any impact on the persecution of Shi'as in the country. Furthermore, despite Mahathir's apparent commitment to encouraging intra-Muslim unity, it should be remembered that the 1996 ban on Shi'ism was issued during his administration, and that he even supported a move initiated by the Chief Minister of Kedah (Mukhriz Mahathir, his son) to ban Shi'ism in the state.⁴¹ Thus, while Mahathir believes that Sunnis should accept Shi'ism as part of Islam (Islam Indonesia 2018), he has said that Shi'ism should not take root in Malaysia (Nur Hasliza Mohd Salleh 2019).

Based on this, it can be argued that Mahathir's motivations in de-escalating sectarianism are motivated by political factors, and not religious or theological ones. This is also evident from his role in organizing the KL Summit in 2019, during which he provoked Saudi Arabia by inviting representatives from Qatar, Turkey, and most significantly, Iran. Viewed as a platform for the formation of a new bloc of Muslim nations, the summit was a source of anger for Saudi Arabia, which had put pressure on Pakistan and other Muslim countries to withdraw from the summit (Prashant Waikar and Mohamed Nawab Mohamed Osman 2020). In response to anger from the Saudis, the Turkish president Recep Tayyip Erdogan emphasized that the summit would be a good platform to "talk freely about our issues, from Islamophobia to terrorism, divisions, internal fights ravaging our region, and sectarian and ethnic conflicts" (*Free Malaysia Today*, 19 December 2019).

The event was met with varying responses in Malaysia. Kua Kia Soong, the advisor to SUARAM, an influential human rights NGO in Malaysia, praised the event, saying that seeing the Iranian President share the same stage with the Malaysian prime minister would give Malaysian Shi'as hope that discrimination and oppression in the Muslim world would be addressed (2019). In contrast, an organization of pro-Saudi clerics known as Pertubuhan Ilmuan Malaysia (iLMU), was not happy. In response to the event, they organized a convention on the Islamic knowledge and invited Syekh Abdurrahman Ibrahim Al-Rubai'in, the

Religious Affairs Official at the Saudi embassy in Kuala Lumpur to speak. During this convention, Al-Rubai'in referred to Shi'as as deviants and said that Islamic ecumenicism was a futile effort as Shi'as had their own Qur'an.⁴² The convention then ended with six resolutions to curb the spread of Shi'ism in Malaysia, as well as a suggestion to request for the King to intervene. They also sought to recognize only the Organisation of Islamic Cooperation (OIC) as the sole platform for Muslim nations to get together (Wan Faizal Ismayatim 2020).

Chandra Muzaffar himself has also been active in de-escalating sectarianism.⁴³ A well-known scholar, and leader of JUST, Chandra has emphasized that "Shi'ism has been a major force in shaping Muslim history, philosophy, science and culture", and that the only reason Shi'as are treated badly in Malaysia is because of the religious establishment who "have seen themselves as the protector, the custodian of Islam and Muslims in the country" and who feel the need to "preserve the purity of the Shafi'i legal school" (2005, p. ix).

JUST has been actively working to de-escalate sectarianism through its promotion of the Amman Message as its core theme.⁴⁴ Amid the

conflict in Syria between 2012 and 2015, Chandra noted that “the antagonism towards Shi’ites, based on false narratives in Syria, reached a crescendo and there were elements in government circles and NGOs in Malaysia pushing these sentiments”. He then emphasized that Malaysia was a signatory to the Amman Message, with leaders such as Anwar Ibrahim and Khairy Jamaluddin signing it (Augustin 2018). However, the efforts initiated by JUST may not always be well received. In 2019, JUST attempted to organize a seminar on “The Amman Message” but was forced to cancel it as a Facebook user had threatened to bomb the venue for the seminar, the International Institute of Advanced Islamic Studies (IAIS). Chandra referred to the user, who commented through the account “Gerakan Banteras Syiah” (“Movement to Stop the Spread of Shi’ism”), as a terrorist threat (2019).

Similar to Abdul Hadi Awang and Mahathir Mohamad, Chandra Muzaffar also views sectarianism as part of the larger problem of Western hegemony, and he is known to be close to Iran and to have made statements criticizing the US, Saudi Arabia, and Israel (IRNA 2018). However, while Chandra Muzaffar has been consistently vocal about the discrimination against Shi’as, his efforts may be hampered by the fact that he is the only known face of JUST. Furthermore, if JUST organizes events, these events tend to be small-scale seminars which are conducted in English, and which are therefore only picked up by the English-language media. Consequently, its efforts may not reach the Malay-speaking masses. Additionally, JUST is not very well known among

culminating in the establishment of the International Islamic Fiqh Academy of Jeddah in July 2006 (The Amman Message). The Islamabad Declaration was also issued based on the Amman Message. Adopted by the Thirty-Fourth Session of the Islamic Conference of Foreign Ministers under the purview of the OIC, the declaration reads that “no Muslim, whether he or she is Shi’ite or Sunni, may be subject to murder or any harm, intimidation, terrorization, or aggression on his property; incitement thereto; or forcible displacement, deportation or kidnapping. Malaysian human rights NGOs, and is often absent from meetings with bodies such as the United Nations.

Another individual who has been active in de-escalating sectarianism is Singapore-based Malaysian sociologist, Syed Farid Alatas. While he is an academic like Chandra Muzaffar, Alatas appears to have a significant following among educated youth in Malaysia. Since 2010, Alatas has held several closed-door meetings, during which he engaged with various individuals and organizations to initiate efforts to de-escalate sectarianism and to champion a more sensible and progressive Islam.

Similar to Chandra Muzaffar, Alatas' efforts include correcting misinformation about Shi'ism, and emphasizing that Wahhabism is the force behind sectarianism. However, unlike Chandra, he is not viewed as a champion of Iran on the global stage, or solely as a human rights defender. Instead, he encourages Malaysian authorities and educational institutions to engage with Iran as a civilization or country which has a lot of knowledge to offer. In fact, he has arranged several academic engagements between Malaysian and Iranian university officials. Occasionally, he uses academic settings to remind Malaysians to be more vigilant of Wahhabism and that the discrimination against Shi'as is immoral (Chung 2019).⁴⁵ However, while his efforts are important, they can easily be stifled by the fact that he works in an academic setting, unlike the drivers of sectarianism who have more resources at their disposal and who have greater access to the masses.

THE ATTRACTION OF SECTARIANISM

As a recap, it is to be noted here that the UKM seminar in 1992 was organized by Pusat Pengajian Umum, based at UKM, and was held at the Dewan Mukhtar in Pusat Islam, Jalan Perdana, Kuala Lumpur. It was a state-sponsored event which was attended by 500 participants, including religious authorities and religious teachers from all states in the country (Sulaiman Noordin 1996, p. x). In contrast, the seminar organized by

PUM in 1993 was not state-sponsored, and most of its participants were non-partisan clerics. Furthermore, it was supported by PAS, which was an opposition party at the time.

Thus, considering the support that the 1992 seminar received, it is little wonder that it garnered much attention and that the ideas that came out of it were able to take root in mainstream society.⁴⁶

Even the police force is inclined towards sectarian tendencies. Ayob Khan Mydin Pitchay, the principal assistant director of Bukit Aman's Special Branch counter-terrorism unit, said in 2016 that any effort to curb violence, militancy or terrorism tends to be painted as pro-Shi'a. According to Ayob, the Wahhabi militants' approach is to label the authorities as pro-Shi'a, thus making it difficult for the police to catch them, as they do not want to be labelled as such.⁴⁷

Nevertheless, people have expressed their grievances about the ills of Wahhabi ideas. For example, in 2009, mainstream Malay-language newspapers exposed that Wahhabis have been insulting Sunnis, and traditional Sunni clerics have lamented that Wahhabis are creating disunity among Muslims. For example, Mahfuz Muhammad, an official

from the Selangor Islamic Council (MAIS) warned authorities to look into the Wahhabis as they are spreading *takfiri* ideas (Roslan Ibrahim and Mohd Fadly Samsudin 2009, p. 4).⁴⁸ Even Zamihan Mat Zin, a cleric who has demonized Shi'as, warned that Wahhabis have “encouraged society to spread violence” and that they have resulted in “intensified discrimination against minority groups” (2017, p. 235).⁴⁹

In 2010, Malaysian authorities suspected that Wahhabi militants were recruiting new cadres on Malaysian campuses (*Kosmo*, 28 December 2010). However, these suspicions, and possibly subsequent discoveries, were kept hidden, and there was a sudden outbreak of sectarianism that lasted for almost a decade, de-escalating only temporarily after the 14th General Elections in 2018. One could easily follow the news coverage between 2010 and 2014 to get an idea of how intense the persecution of Shi'as was at that time (see Appendix).

In a 12 November 2014 Federal Government Gazette concerning Anti-Money Laundering, Anti-Terrorism Financing and Proceeds of Unlawful Activities, the Malaysian government listed thirty-nine individuals as being involved in attempts to create violence in Malaysia. They were linked to thirteen organizations that were perceived as Wahhabi, Deobandi, and Jihadi Salafi groups such as Abu Sayyaf, Islamic State, Al-Shabab, Boko Haram, Jemaah Anshorut Tauhid (also known as Laskar 99), and Mujahidin Indonesia Timor.⁵⁰ Between 2 May 2014 and 15 January 2016, there were twenty-five arrests involving eighty-four Wahhabi individuals who planned to sow violence in the country (*Utusan Malaysia*, 19 January 2016, p. 15).

These concerns and arrests point to one thing: Shi'as pose less of a threat to national security than Wahhabis do. This was articulated by Hishammuddin Hussein, the Minister of Home Affairs at the time, who said that “the Shi’ites are not a threat from a security point of view” (Mazwin Nik Anis and Zulkifli Abdul Rahman 2010). Scholars also share this view. For example, Curtin Winsor Jr. (2007, p. 10) highlights that “Shi’ites do not regard non-Shi’ite Muslims as unbelievers”, and that because they comprise such a small portion of the global Muslim population, their numbers “make any project of revolution impractical”. Furthermore, their absolute loyalty to the clerical establishment (*marja'*) would make any *jihadi* attempt against the state impossible, unless they receive official dictation to do so.⁵¹

Yet, Shi'as have become double targets. Not only are they persecuted by the state, but they are also exposed to the risk of terror attacks from Wahhabi militant groups. In 2016, Ahmad Zahid Hamidi, the Minister of Home Affairs at that time, highlighted that between 2014 and 2016, Wahhabi militants were making progress in their plans. These plans included attacking a Shi'a mosque in Kedah, attacking tourist attractions, stealing weapons, and even attempting to abduct national leaders (2016, pp. 8–9). While these efforts were thwarted by the government, they still pose a formidable threat, as they still receive funding from Muslims who believe that Shi'as are infidels and who wish to contribute to ISIS activities in the Middle East (*Malay Mail*, 22 May 2016). There are even videos posted by Malaysian militants living in the Middle East who

encourage those living in Malaysia to kill the police and the enemies of Islam, such as Shi'as, by beheading them and stabbing them in the chest (*Free Malaysia Today*, 23 June 2016). Considering all these factors, it is crucial that sectarianism be curbed and de-escalated, so as to prevent further outbreaks of violence and terrorism.

CONCLUSION

There is no question that sectarianism leads to the violation of human rights. In the case of Malaysia, sectarianism and the consequent discrimination against Shi'as have been institutionalized and implemented in a systematic manner.

In 2019, Dr Wan Salim Mohd Noor, a prominent cleric from PUM, who is also the Mufti of Penang, suggested that Malaysia look into teaching a basic introduction on Shi'ism in schools. In an interview with the news platform *Malaysiakini*, he emphasized that education and schools are the keys to ending Shi'aphobia in Malaysia (Loone 2019). Maszlee Malik, then the Minister for Education, voiced his support for the idea (Yasmin Ramlan 2019).

The idea for the basic tenets of Shi'ism to be taught in schools is not a new one. In a lecture entitled "Preliminary Thoughts on the Nature of Knowledge and the Definition and Aims of Education" delivered at King Abdul Aziz University in Jeddah, Syed Muhammad Naquib al-Attas raised the issue (1979, pp. 19–47). The following year, he raised the issue again in his book *The Concept of Education in Islam: A Framework for an Islamic Philosophy of Education*:

The core knowledge representing the *fardu 'ayn*, integrated and composed as a harmonious unity at the university level as a model structure for the lower levels, and which must invariably be reflected in successively simpler forms at the pre-university, secondary, and primary levels of the educational system throughout the Muslim world, must reflect not only the Sunni understanding of it, but also accommodate the Shi'i interpretation (1981, p. 42).

However, what would have been a progressive move to de-escalate sectarianism was ignored, and today seminars about the alleged ills of Shi'ism are still being organized in Malaysia.⁵²

Yet, Islamic ecumenicism is possible as long as Muslim clerics have the desire to understand the root of sectarianism, and to work towards de-escalating it. As Ussama Maksidi put it, it is crucial that sectarianism, as a “modern reality,” “be understood before it can be dismantled” (2001, p. 19). While it has been decades since the seeds of sectarianism have been planted in the minds of Muslims in Malaysia, giving rise to concerns that such tendencies would be difficult to uproot, it is worth referring to Seyyed Hossen Nasr’s words as a form of motivation to de-escalate sectarianism:

The response to challenges to Islam must also be based on the most universal and all-encompassing teachings of Islam avoiding narrow sectarianism and opposition within the Islamic world itself, leaving sectarian and theological or juridical disputes to jurists or theologians and religious scholars who have had the necessary training to carry out such debates. Of course, even in their case, the day has come for them to be able to adopt the larger view of Islamic orthodoxy based on the two *shahadahs* and the universality of the teachings which have emanated from the

Whereas Al-Attas’ scheme was broad enough to accommodate even Shi’a interpretations of the revealed sciences, Malaysia has been fastidious in instituting pre-emptive action against and punishment of Malay-Muslims who profess the Shi’a variant of Islamic faith deemed to have deviated from the path of Sunni orthodoxy” (2010, p. 52).
